# President's Message

## *“Kintsugi” Our Professional Culture & Legacy*

*“When the Japanese mend broken objects, they aggrandize the damage by filling the cracks with gold. They believe that when something’s suffered damage and has a history it becomes more beautiful.”*

**T**he story of **Kintsugi** may have begun in the late 15<sup>th</sup> century, when a shogun sent his favorite, damaged Chinese tea bowl back to China to be fixed. It returned held together with ugly metal staples, launching Japanese craftsmen on a quest for a new form of repair that could make a broken piece look and symbolize “better than new”.

The story of **Kintsugi** may have begun in the late 15<sup>th</sup> century, when a shogun sent his favorite, damaged Chinese tea bowl back to China to be fixed. It returned held together with ugly metal staples, launching Japanese craftsmen on a quest for a new form of repair that could make a broken piece look and symbolize “better than new”.

The subtlety of this philosophy focuses on imperfections themselves rather than attempting to disguise them. Often we try to repair broken things in such a way as to conceal the repair and make it “good as new”. Instead, by aggrandizing the damage and venerating the object complete with flaws, kintsugi expresses the belief that part of what makes our legacy interesting and beautiful are the very things that so many of us try to sweep under the rug or otherwise obscure from view.

As an art form and philosophy, kintsugi points to valuing the history of something that has been broken and is made whole again in a new identity. Our western culture tends to discard the broken-broken objects, broken people, and broken relationships. We fail to see what the broken might look like if we put the resources into mending them.

I believe the **Kintsugi** concept and the term “aggrandize”-to widen in scope; to enlarge, to make great or greater have a poignant application to the culture and legacy of Access to Care. Who knows more about ceramic and gold or “fixing things” than Dentists? Dentists continue to perfect the art and science of restoring the human dentition. We get so used to the way things are and don’t always see the opportunity for so much more than this. We live in the “normal” and forget there is a higher good to manifest. I will submit to you that we don’t have to accept the limitations that we’ve known because we’ve come to this place to deliver something more profound...to help restore and honor the human condition...along with the human dentition.

My laser beam and that of the West Coast District Dental Association continues to be focused on Access to Care. To that end we started last summer with the WCDDA leadership visiting St. Matthew’s House, a homeless shelter and recovery program in Naples to see firsthand the overwhelming need for dental services. We continued this past fall with exciting dialogue amongst members and leadership alike during my affiliate visits to explore innovative ways to make it easier for our members to volunteer; to actively address programmatic service needs on a local level.

We can be very proud of the dedicated and insightful work of our newly-formed Access to Care (A2C) Committee. Their charge is to develop and maintain a **WCDDA Center for Strategic Service** (with corresponding 5 year strategic plan) whose function is to champion the Service Component of Access to Care and support professional volunteer efforts at the affiliate level. This includes:

- ✓ developing a “cohesive message” that promotes the organizational and member benefits associated with professional volunteerism.
- ✓ developing and maintaining related “service” resources
- ✓ developing a public relations “awareness”/fundraising model
- ✓ coordinating all related legislative “awareness” opportunities, and
- ✓ to help reach our goal, in 5 years that 75% of our members are actively volunteering with a recognized non-profit organization, clinic, referral-based program, once a month providing comprehensive dental care to the underserved throughout the West Coast of Florida.

I want to acknowledge the important work of the **Florida Dental Health Foundation** (FDHF) and its Project: Dentists Care-affiliated clinics/programs. We continue to learn about the wonderful impact of existing programs like **Dr. Robert Ettleman’s Gulf Coast Dental Outreach (GCDO)**, **Dr. Bill Truax’s Project Dentists Care** program in Lee County, **Dr. David O’Sullivan’s Dental Outreach of Collier (DOC)**, the involvement of **Drs. Amy Anderson, John Thee** and others with **Pinellas Coalition, PCDA Mission**, **Dr. Jim Little’s Dental Program with Community Coalition on Homelessness** in Bradenton, and the excitement of the much-anticipated **Brandon Outreach Clinic** organized by **Drs. Craig Oldham, Reza Iranmanesh** and others from

Hillsborough County to name a few. The committee is working diligently to bring the resources together (programs, volunteers, facilities) while developing the concepts of prevention, patient education and personal responsibility, transportation, funding, etc.

My special thanks to Chairman **Dr. Chris Bulnes**, and his A2C Committee members **Drs. Amy Anderson, Zack Kalarickal, Bill Kochenour, Larry Lieberman** and **Chris Wujick** and our great staff **Lissette & Kelsey**.

As we enter a new year I ask for your continued help to more fully develop the culture and legacy of service within organized dentistry and to support the efforts of our Access to Care (A2C) Committee. If you are already volunteering, my heartfelt thanks. If you're not I encourage you to embrace the value of being part of something bigger through your service to those in need. The rewards will foster personal growth, bolster organized Dentistry's position as leaders in oral health care, and encourage others to join our cause.

The need in our communities is overwhelming. As Kintsugi artisans, we are the "gold vein" that can pull the pieces together beautifully... and make a difference.

**Kintsugi** (Japanese: *golden joinery*) is the Japanese art of fixing broken pottery with a lacquer resin sprinkled with powdered gold. Kintsugi may have originated when a shogun sent a damaged Chinese tea bowl back to China for repairs in the late 15th century. When it was returned repaired with ugly metal staples, it may have prompted Japanese craftsmen to look for a more aesthetic means of repair. Collectors became so enamored of the new art that some were accused of deliberately smashing valuable pottery so it could be repaired with the gold seams of kintsugi.

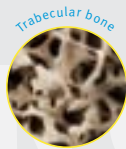
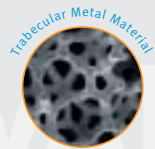

There will be a caucus of the West Coast District Dental Association's Delegation on Tuesday, January 22, 2013 at 6:00 p.m. via conference call. There will be twelve sites throughout the West Coast district.

The West Coast District Dental Association will hold a breakfast caucus in conjunction with the Florida Dental Association's House of Delegates meeting Saturday, January 26, 2013 at 7:00 a.m. at the Tampa Airport Marriott.

The House of Delegates of the West Coast District Dental Association will meet in session on Thursday, February 14, 2013 at 3:00 p.m. in conjunction with the WCDDA's Annual Meeting at the St. Petersburg Hilton Bayfront.

Pursuant to the WCDDA Bylaws, all WCDDA members are hereby notified of the possibility that the WCDDA House of Delegates (HOD) will be asked to consider bylaws changes. The proposed bylaws change pertains to the membership category and will read as follows:

## CHAPTER I \* MEMBERSHIP

### Section 6. APPLICATION FOR MEMBERSHIP

Resolved, ELIMINATE Active Life Member category from the West Coast District Dental Association's membership category.

### B. GENERAL EXEMPTIONS

Retired life, privileged and honorary members shall be exempt from payment of any dues and assessments to the West Coast District Dental Association. ~~Active life members shall be exempt from payment of one half (1/2) West Coast District Dental Association dues.~~ Active life members are exempt from payment of West Coast District Dental Association assessments.

The WCDDA's Article of Incorporation allow the FDA Bylaws to be amended by a two-thirds affirmative vote of the HOD, provided the proposed amendments are sent in writing to the membership of the association and postmarked at least 30 days in advance of the HOD session; or at any HOD session by a three-fourths affirmative vote, provided the amendments were presented in writing to a previous session of the HOD and unanimous consent is given for their consideration

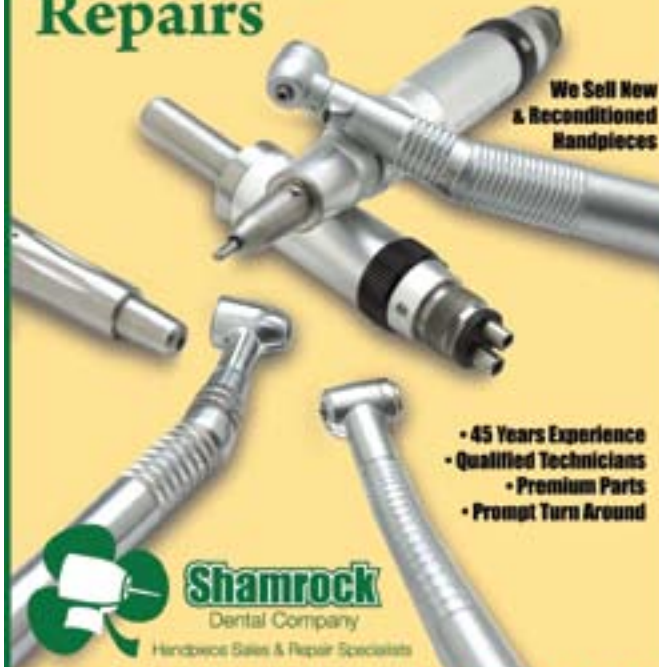

## Convenient Dues Installment Options Offered to Members for 2013

The FDA has created a convenient installment option to make it even easier for you to renew your membership for 2013! Enrolling in the program is simple. When you receive your dues statement, check the "Credit Card Payment Plan" option in the lower-left corner; fill out your credit card information and sign the form. Then simply mail or fax your dues statement stub to the FDA. Members who enroll in the installment plan will fulfill their dues obligation by the end of October 2013. Other payment methods also will be accepted, including payment by check or online with a credit card. Contact the Florida Dental Association (800) 877-9922 for more information or to enroll.

## Health Care Practitioner; Waiver of License Renewal Fees and Continuing Education Requirements – 766.1116

Any health care practitioner who participates as a health care provider under s. [766.1115](#) and thereby agrees with a governmental contractor to provide his or her services without compensation and as an agent of the governmental contractor to low-income recipients in accordance with s. [766.1115](#) for at least 160 hours for each biennial licensure period, or, if the health care practitioner is retired, for at least 800 hours during the licensure period, upon providing sufficient proof from the applicable governmental contractor that the health care practitioner has completed the hours at the time of license renewal under procedures specified by the Department of Health, shall be eligible for: (a) Waiver of the biennial license renewal fee for an active license; and (b) Fulfillment of a maximum of 25 percent of the continuing education hours required for license renewal under s. ## ADA Updates Dental Radiograph Recommendations

The ADA, in collaboration with the Food and Drug Administration, has released updated recommendations for the prescription of dental radiographic examinations. "Dental Radiographic Examinations: Recommendations for Patient Selection and Limiting Radiation Exposure," which was last updated in 2004, should serve in conjunction with dentists' professional judgment on when it's appropriate to use diagnostic imaging. Radiographs can help dentists evaluate and diagnose many oral diseases, but the ADA also recommends that dentists weigh the benefits of taking dental radiographs against the risk of exposing a patient to X-rays, the effects of which can accumulate from multiple sources over time. The dentist is in the best position to make this call since he or she knows the patient's health history and their vulnerability to oral disease.

Highlights from the updated document include:

- Removing a stronger recommendation for thyroid collar use for children, women of childbearing age and pregnant women. The strength of the recommendation is now the same for all patients.
- A new section that was not in the 2004 document, which expands upon the 2006 CSA report, "The Use of Dental Radiographs: Update and Recommendations."
- New topics that were not covered in the 2006 CSA report such as receptor selection, handheld X-ray units, technique charts and radiation risk communication.
- Changing the recommendation for shielding to be consistent with the National Council on Radiation Protection & Measurements.
