

# Dentists' Day on the Hill TESTIMONIALS:











"After having a Florida dental license for 30 years, I finally attended my first Dentists Day on the Hill event. It was very interesting to see political processes at work and to understand in more detail, the issues that are affecting the dental profession. I would recommend it to other doctors. I was never interested in politics in general, but I now have a greater appreciation for it. The day itself was like running a race from office to office trying to catch the legislators in order to be heard. Towards the end of the day we all sat in on the children and families committee meeting, and that was an eye-opening experience. We listened to the different bill proposals and presentations from different lobbyist's and individuals who are trying to influence the senators to vote in their favor. As I sat and watched the legislators vote on the different bills, I got a better sense of just how important our presence is there. I also got to see how hard the FDA administrators and lobbyist's work to protect our profession. At the committee meeting one of the senators asked all the dentists to stand. We represented over half of the room and it was powerful! It is important if we want to protect our profession, for dentists to commit to becoming active! I think it's like anything; we all do it when we're ready, but it is important that eventually we all step up and do our part."

"Early February, a handful of dentists, both young and practiced, dental students, and several spouses travelled to Tallahassee to lobby for our profession. We traded in our scrubs for business casual attire and left the loupes at home. Entering the Florida State Capitol was slightly different than walking into a dental office on a [Tuesday] morning. I felt a sense of awe and inspiration walking into the rotunda, shoes clinking on the marble floors, and countless groups of people from various organizations hustling to their next meeting with senators and representatives.

This year was particularly important for our profession. We were primarily focusing on shutting down SB 152, which promotes dental therapy legislation in Florida. This bill would lower the standard of care by introducing a new licensed dental provider, known as a "dental therapist". A dental therapist would undergo a 3-year training program right out of high school, and then be authorized to perform irreversible procedures such as the administration of local anesthesia, extractions, restorations, and partial root canals.

We urged members of the Legislature to support the Dental Student Loan Repayment Program, and to allocate funds for the Donated Dental Services program. Supporting the Student Loan Repayment Program would provide funding to place dental graduates in underserved areas to work as full-time Medicaid providers, during which time they would receive \$50,000 toward their dental school loans each year for a maximum of 5 years. Funding for the Donated Dental Services Program would allow for two full-time coordinators to be employed and would cover operational expenses and allows dentists and dental labs to donate free dental care to those who cannot afford care, or who are disabled, elderly, or medically compromised.

#### **DDOH Continued**

Now what are a bunch of dentists with light up toothbrush name tags doing on Capitol Hill? Throughout the day we met with a several Senators and Representatives from across the state, during which time we shared why certain pieces of legislation matter to us and how they affect our profession. Who would know better than the professional who deals with the outcome of these matters daily? That was our purpose on the hill. Many of us spoke our minds regarding matters that mean the most to us. Current dental students expressed their concern with the high amounts of student loan debt most young dentists face upon graduation. The fact that legislators took the time out of their busy schedules to meet with us shows that they indeed care about the future of our profession.

One of my favorite moments from DDOH happened during a Senate Committee Meeting. The committee was voting on the Dental Therapist legislature. One of the legislators asked all the dentists in the room to stand up. 150 dentists stood up! It was a sight to see. We may have been the reason why this bill was temporarily postponed that day.

Although we weren't relieving a patient from pain by initiating a root canal or delivering an anterior crown case, we were making a significant impact on our profession for the days and years to come. The most important thing we can do is voice our concerns and express the importance of organized dentistry because there is no better way to preserve and protect our wonderful profession!"







# HYPERTENSION AND ORAL HEALTH

Risks can be magnified while undergoing dental care

Back in the days of dental school, we all learned how to use a sphygmomanometer and stethoscope to measure the blood pressure of all patients. This was an essential step in our process of checking our patients' readiness for any dental procedures. This is considered the standard of care. Heaven forbid we would ever ask for a starting check from an instructor without first providing this essential information. To omit this step would surely land us in a hot seat for negligence from the especially stern professors. Yet after entering private practice, do you or your staff still perform this simple and revealing exam of your patient's vital signs?

It is important to keep in mind that a significant number of your patients may have poorly controlled or undiagnosed hypertension. Patients sitting in your treatment chair with elevated blood pressure are at higher risk of experiencing a stroke or myocardial infarction. In this disease state there is additional stress placed on the ventricles, an increase in heart rate, and increase in oxygen demand that can all lead to cardiac compromise. Risk for such cardiovascular events is magnified by procedural stress, epinephrine exposure, and even the dreaded "white coat syndrome".

Hypertension, known as the silent killer, is on the rise in the United States.


According to the 2011-2012 National

Health and Nutrition Examination Survey

I would like to suggest the best course of action is to visit with your medical colleagues. Compare notes with them and develop your own protocol for hypertension that best fit your patient population.

(NHANES), 1 of 3 US adults has high blood pressure with nearly half (48%) that do not have their blood pressure under control! A closer look at this uncontrolled group revealed that one-third is not even taking their medications. It is not safe to assume all patients are in compliance with their medication protocols. Even if they list hypertensive medications on your health form, they may only take the medications when they "feel bad". At every visit there should be a review of medication to detect any changes as well as inquiring to the frequency of use. As a dentist, you have the opportunity to continue educating your patients about the need to follow doctor's orders to keep hypertension controlled.

So what values are we to consider when evaluating our patients? The Joint National Committee on Detection, Evaluation, and Treatment of High Blood Pressure defines hypertension as a systolic blood pressure greater than or equal to 140 mmHg or a diastolic blood pressure greater than or equal to 90 mmHg as recorded during two or more readings on two or more occasions. That may be true for national values, but here in Arkansas those types of readings could well be considered the "Southern norm." If we held to that standard and did not treat patients unless their BP was lower than this mark, nearly two-thirds of the patients recently treated at the last ArMOM event in Monticello would have been denied treatment. I would like to suggest the best course of action is to visit with your medical colleagues. Compare notes with them and develop your own protocol for hypertension that best fit your patient population. Set the values for what you will consider pre-hypertensive, Stage 1, and Stage 2 in a format for staff to reference (see example). When hypertension is detect in a patient you have protocols in place for treatment and/or referring to a primary care physician.



Patients deemed to be Stage 1 hypertensive, treatment may still progress with precautionary measures. This is an ideal time to discuss the effects of hypertension and recommend a follow up with their physician to determine the best course of action to control the problem. The use of local anesthesia with a vasoconstrictor is permissible and advised. However, the dosage should be kept to a minimum and not extend beyond 0.04mg of epinephrine. A single cartridge of lidocaine with 1:100,000 concentration of epinephrine contains 0.018 mg of epinephrine. Even though the half-life of epinephrine is short, it is best not to extend beyond 0.04 mg (two cartridges) without continuous monitoring of cardiac status.

Patients that are detected in Stage 2 hypertension should not have dental treatment as a safety precaution. Instead this is the time for referral to a primary care physician. Delaying your treatment

may also serve as a warning to the patient that this is a serious event and not to be taken lightly. Advising your patient that you will need medical clearance before proceeding with even the most routine services such as dental prophylaxis can serve as a subliminal 'wake up' message of urgency.

Dental care is one of the few medical services that a large proportion of the population utilizes for routine preventive services. This is a perfect opportunity to check your patients for signs of dental issues and to provide a simple screening check to determine the presence of hypertension. Patients that have controlled hypertension may require special attention due to side effects from medicine. Issues such as xerostomia are common with many of the hypertensive medications used today.

Many people with dry mouth may resort to lozenges/candy as a means to stimulate saliva but doing so increases the incidence for dental decay. Gingival hyperplasia may result if the patient is taking calcium channel blockers. Based on the patient's medical history and oral examination, you may need to modify the frequency of preventive services three or four times a year in order to help these patients better maintain good oral hygiene.

There is an ongoing effort to develop a balanced health care delivery from all health professionals. As a dental profession, we are in a position to help guide our patients toward interceptive care should we discover a hypertensive patient. Early detection and treatment of high blood pressure results in better patient outcomes and may alert you, and the patient, to a very serious undiagnosed health issue. It is our professional responsibility to inform our patients of their hypertensive condition, to offer medical advice, and to provide referrals as indicated. **AD**

# Friday, August 7th

# HPV & EBV Viruses are Causing an Epidemic of Cancerous and Precancerous Lesions in the Oral Cavity Dr. Donald Cohen

8:00 a.m. - 11:30 a.m., 3 CEUs

This series of seminars will present a potpourri of interesting case studies in oral and maxillofacial pathology covering a variety of conditions encountered in general and specialty dental practices. The presenter will utilize an audience response system called Poll Everywhere, which will enable participants to use their cell phones to anonymously respond and interact with the presenter. In addition, the lecture will be customized by the audience responses and questions to better facilitate learning. Emphasis will be placed on lesions and conditions commonly seen in dental practice, especially those difficult to diagnose or to manage, newly diagnosed conditions and, especially premalignant or early malignant lesions.

The first seminar will focus on HPV and EBV viruses, which are causing an epidemic of cancerous and precancerous lesions and recalcitrant ulcers in the oral cavity. The lecture will demonstrate how to recognize these lesions and what we as dentists can do about them.

# Saturday, August 8th

## Clinical Features of Early Oral Cancers and Precancerous Lesions Dr. Donald Cohen

8:00 a.m. - 11:30 a.m., 3 CEUs

This seminar will focus on early oral cancers and pre-cancers, especially their clinical features. Early forms of cancer often have specific patterns based on location. Gingival cancers and especially pre-cancers have recently presented with a new clinical appearance. I have coined the appearance "ring around the collar." This innocuous-looking circumferential leukoplakia of the marginal gingiva is very important to recognize and treat early. Also gingival cancers often resemble gingivitis and erythroplakia must be distinguished from chronic gingivitis. Multiple examples of early cancers from all oral and oropharyngeal sites will be shown to improve the clinician's ability to recognize these often benign-appearing lesions.

# Potpourri of Oral Pathology Dr. Donald Cohen

8:00 a.m. - 11:30 a.m., 3 CEUs

The third seminar will be entitled "Potpourri of Oral Pathology." This will consist of a series of interesting clinical cases taken from the archives of the large oral pathology database at the University of Florida. These cases will challenge the diagnostic acumen of the course participants and help markedly improve their ability to recognize some important pathologic entities.

#### COURSE OBJECTIVES:

- 1. Upon completion of the three courses, participants should be able to recognize and formulate a differential diagnosis and understand the etiology and management of various oral lesions and diseases.
- 2. Recognize and understand the association of HPV with numerous oral lesions and the enormous implication of HPV-driven cancers and lesions to our dental practice. EBV-related ulcers have recently been seen in older patients and patients who are immune compromised. These ulcers are recalcitrant and difficult to treat and must be managed differently.
- 3. Recognize the clinical features of early squamous cell carcinoma and other malignancies of the oral cavity.
- 4. Better recognize abnormalities.
- 5. Improve diagnostic skills and management techniques of oral soft and hard tissue lesions through practice sessions utilizing anonymous audience response device.
